I, and my heirs, executors, and administrators, will not hold Riverside Equestrian Centre Inc. or Riverside Farm or any employee(s), officers, representatives, agents, and directors thereof responsible for, and waive any and all claims I may have against any or all of them if injury, death, damage of property or loss of any kind whatsoever nature or kind and howsoever caused whether arising by reason of the negligence of Riverside, its employees, agents or representatives, to myself, my horse, my property, or anyone in my care while at Riverside Equestrian Centre and or Riverside Farm.

I agree to hold harmless and indemnify Riverside Equestrian Centre Inc., its agents, directors, officers, employees, agents and representatives from any and all liability for any damage to property of personal injury to any third party resulting from my use of the facilities, horses, services, or presence on the property provided by Riverside.

# LESSON RULES AND POLICIES RIVERSIDE EQUESTRIAN CENTRE INC.

As a condition of taking riding lessons with Riverside Equestrian Centre Inc. you are required to sign this rules and waiver document.

**The purpose of this document is to outline the rules and policies of Riverside Equestrian Centre Inc. which the rider and guardian agrees to abide by.**

Riders must wear boots with a heel (one inch minimum), long pants, and a proper riding helmet. Baggy clothes are not suitable. Form fitting clothes with the tops tucked-in is appropriate wear.

Instructors may change depending upon scheduling.

Students on school lesson packages should be picked up no later than 30 minutes after their lesson. Students picked up later than 30 minutes after their lesson will be charged a \$10 supervision fee. They will also be charged \$10 for every 30 minutes thereafter. This does not apply during special events i.e.: horse shows etc. All school lesson students are welcome to all special events and functions at Riverside Equestrian Centre.

**Riders should arrive 20-30 minutes before their riding lesson. Lessons end on time even if the rider is late to start. Riders who are late for their riding lesson may lose the opportunity to ride. These lessons will not be refunded or credited.**

**All cancellations require 24 hours notice, or the full lesson rate will be charged**

**Cancellations with less than 24 hours notice but before 3.30pm weekdays will be assessed a 25\$ late fee, no exceptions. Weekend cancellations require the full 24 hours notice.**

All students 19 years or older must sign a waiver of right to sue. All students under the age of 19 must have a parent or guardian sign a waiver of right to sue. All students must fully complete a personal data form.

Payment for lesson packages are due before the first lesson is taken. **No refunds for lesson or lease packages.** Cheques for riding lessons and leases must be made out to **Riverside Equestrian Centre Inc.**

I agree to abide by the above rules and policies as a condition of taking riding lessons.
